2020 SUO of UBC Future Plan

The Students' Union was formed to serve the students of UBC Okanagan as an invaluable service, providing key pillars of advocacy, services, and campus life. Since its establishment, the Union has struggled to fulfill this essential obligation of being recognized as a positive asset to the student body. The 2019/2020 SES found that **the SUO averaged a rating of just 5 out of 10 among the students of UBCO**. We must be constantly adapting to the ever changing landscape of the University, as well as the students we represent. As a student funded organization, we must ensure our existence is justified by the benefits we provide our members.

The current structure of the SUO leaves several gaps in terms of fair representation of members, as well as its ability to be evolve as an organization. The distribution of the Board of Directors (BOD) makes 17 Directors the maximum size of the voting Board, a number far too small to be an adequate representation of the SUO's membership, currently 12,000 up to a minimum of 20,000 by 2040. We must look to grow our Board in order to ensure that we are accurately representing the members of our Union as well as their diverse backgrounds, views and values.

As a Union, we must also take radical steps steps to ensure that we are addressing the foremost issue affecting our members today; space concerns. Our members identified space concerns as one of their top priorities, with a majority stating that lack of adequate study, and recreation space has had severe impacts on their academics, physical wellbeing, and mental health. The SUO must take the initiative that almost all of our counterparts around the country have done and provide students a space on campus that they can call home.

The following document is a series of proposals encompassing changes to the structure of the Board of Directors, SUO standing committees, and my formal recommendation that the SUO begin the process of working towards constructing a student centre by the end of the decade.

We asked and our students spoke, the Students' Union must work harder than ever this year to ensure we are giving our members a Union that they deserve; one which will be sustainable, democratic and indispensable.

CURRENT MODEL

The Board of Directors (BOD) is intended to be the elected representation of the student body of UBCO. Currently, the distribution of seats on the BOD does not correlate with the size of the constituency, nor the size of each faculty. This means that with no change to the structure of the BOD and a campus population that is increasing significantly every year, the disparity between the makeup of the BOD and the membership it represents will only grow larger.

REDISTRIBUTION

A revised system where seats on Council are distributed according to population of faculties. With each faculty automatically being eligible for one seat and an additional seat after each 700 students, the distribution of representatives on Council will directly correlate with the populations they represent. A guaranteed seat for a student of indigenous descent also ensures representation of UBCO's many Indigenous students.

RECOMMENDATION


The SUO should gradually begin the process of revising the Board structure to be more representative of the student body. As a student funded organization, it is essential that the SUO be directly reflective of its members in order to ensure that they feel their voice is adequately represented.

The most immediate change should be the renaming of the Board of Directors to SUO Council. This would mitigate the long standing confusion among general membership, faculty, staff, community, etc., around the difference between the Board of Directors and the Board of Governors.

DIVERSITY

The 2019/2020 SUO Student Experience Survey confirmed that the Okanagan campus is an incredibly diverse academic community, representing 12 wide reaching ethnic groups and students from over 102 countries. Despite this, our radicalized membership still make up a minority of the campus population. In order to support all of our members and ensure they have a home on campus, the SUO should establish a fourth resource centre to better service these students.



RECOMMENDATION

The SUO should establish a fourth resource centre, taking over one of the office spaces in The Commons. The Commons was a building built by students, for students, so it should be used to provide a gathering space for the some of the most marginalized students on our campus. This resource centre will provide programming, social opportunities, and employment opportunities to radicalized students on the Okanagan campus.

SPACE CONCERNS

The 2019/2020 SES made clear that the students of UBC Okanagan rank study, recreation, and club space as the top concerns for them with **62.59% believing** there is inadequate study space at UBCO, and **37.05% believing there** is a lack of recreation space. **64.44%** of students said that lack of study space has affected their academics, and **35.73% have considered transferring schools** as a result.


The SUO not only has the ability, but also a responsibility to address these concerns.

PROPOSAL

The Students' Union must take extraordinary steps to address these concerns by being proactive and contributing directly to the growth of the campus. This would be achieved by constructing a student centre. The building would be designed, owned, and operated by students. This would ensure that the student body of UBC Okanagan has a place they can call home on campus. This student centre would act as a hub for students, where they can access open study spaces, lounge spaces, a clubs centre, bookable spaces, new services, and have complete control of it so it can fit the ever changing needs of the student body.

THE FORUM

The Forum would be a central hub of campus, being built on top of what is currently parking lot F. This building would be constructed sustainably to LEED certifications, and would be the result of intensive consultation of the student body to ensure every member has the ability to contribute directly to its development.

INSIDE THE FORUM

Following the lead of our counterparts around the world, the students of UBC Okanagan would have their first student centre. This centre would be a retreat for the students of UBC Okanagan. UBC's 2040 plan includes no recreation space, no lounge space, no club space, and little additional study space; The Forum would fill all of these gaps.

This building could contain:

- Hundreds of new study seats
- New lounge spaces
- New food services, providing affordable, healthy and diverse options
- Convenience or grocery stores
- Full-scale bank branch
- Offices for large well established student organizations
- Club Centre with storage space, bookable rooms, hot-desks, and more
- Potential for recreation spaces like a games room, art gallery, rooftop garden, nap room, and more
- Dedicated office space for Pride Resource Centre,
 Women's Resource Centre, Peer Support Network, and new resource centres
- Second on-campus daycare centre
- On campus full-size pharmacy

HOW MUCH WILL IT COST?

The building being designed with sustainability in mind would make energy cost minimal. The addition of adequate conference hosting capability, food service, in-house catering, retail spaces, etc., would make the building completely self sustaining.

Funding for The Forum will come from several sources. The first of which will be a student levy. This levy means that students will be the key stakeholders, and with clear expectations around university funding, it would make the building entirely student owned and operated. A small annual contribution from each student would benefit tens of thousands of their peers over the lifespan of the building.

The second funding source will be donor contributions. UBC has committed to supporting the SUO in acquiring donors for the development. An ecofriendly, student centred building has a strong appeal to UBC's donor community and would bring in significant funding from alumni and community donors.

The SUO would also negotiate with UBC to guarantee they make a significant contribution to the construction of The Forum, as they did the AMS Student Nest in Vancouver. Inclusion of a daycare would also attract university and government funding for the project.
